Voting Procedure:

Ballot Box Voting - Ballot Box In Person Voting – One way in which you are able to cast your votes for these candidates listed below is by visiting the East Business Office and filling in a ballot paper selecting your chosen candidate. This option for voting allows for your vote to be completely anonymous as we only record your name. We record your name in order to ensure only one vote per parent is submitted. Ballot Box voting times are outlined below:

- Tuesday 21st March 08:30 15:00

Email Voting - We have had a number of parents request remote voting due to working and family commitments. Therefore we will still have the email voting option, as other island schools have in recent times. Email votes are to be cast by emailing me directly at Clare.Cayzer@sch.im. However, we are unable to receive your vote anonymously if you wish to use this approach to vote. All votes will be confidential, but we need to be able to verify email addresses so that only parents of current students can participate and to ensure only one vote is submitted per parent. This information will only be held with me and destroyed as soon as the count has taken place.

Anyone who has already cast their email vote will be contacted today to give them the option to change their vote via email or withdraw the email vote if they prefer to vote via the in-person ballot box.

The final count will now take place on Tuesday 21st March at 15:00
